Services will be on a monthly basis for a twelve (12) month contract period.</p> <p><b>SCOPE OF WORK</b></p> <p>The service provider will be responsible for servicing all MBDA and its managed sites with pest control services:</p> <p><b>SPECIFICATIONS / SCOPE OF WORK</b></p> <p>The scope of work entails the appointment a service provide to undertake pest control and fumigation of building structures.</p> <p>The prospective service provider is expected to undertake pest control and fumigation of building structures at MBDA and MBDA Managed Sites as follows:</p> <ul style="list-style-type: none"> <li>a) As per the agreed schedule.</li> <li>b) The bats and termites' treatment that will be conducted at the sites will be undertaken during office hours after an engagement with MBDA's OHS Officer.</li> <li>c) Fumigation to be undertaken at all buildings / facilities with full reports that must be forwarded to OHS Officer who will endorse the reports.</li> <li>d) All pesticides, insecticides, and fumigation substances to be used must be compliant to SABS and SANS code of practice and Department of Agriculture approved.</li> </ul>

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
