- All sewer manholes including pipe diameter, depth, material, invert and cover levels. Manholes must be connected and direction of flow between any two manholes must be shown and;
- All stormwater structures including open drains, piped drains and catch pits. For open drains, provide enough survey points to enable plotting of drain cross sections;
- Telecoms infrastructure including lines, junction boxes, and related equipment;



2. REQUIREMENTS OF THE DETAIL SURVEY

The following requirements should be taken into account when presenting your quotation and the data should please be submitted as indicated:

2.1. Digital Terrain Model

A digital terrain model is required in a format compatible with Civil Designer (version 6.5 or later).

The perimeter of the triangulation (break lines) supplied must be properly closed and the model must be checked by yourselves in order

to ensure that the generated contour lines conform exactly to the shape of the ground. Also, any cross sections or long sections generated from the digital terrain model must reflect the real situation on site.

2.2. Digital Survey Plans

In addition to the digital terrain model, we require digital survey plans to be provided in AutoCAD 2000 or DXF format. These plans must indicate the position of all relevant ground features such as trees, road signs, fences, etc within the required survey area. Watercourses must also be shown together with the direction of flow.

All existing culverts (including the inlet and outlet structures) must be included in the survey. The size, as well as the invert levels at the inlet and outlet must be indicated on the plans.

Contour lines generated from the digital terrain model and shown on the digital survey plan must be rounded and at 0.25m intervals. Contour lines every 5m must be shown with a thicker line when plotted. A paper plot of the survey plan must also be provided (scale 1:1000). All digital information is to be supplied on a CD, with a covering letter briefly describing the content of each file on the disk(s).

2.3. Control Points

A total of 3 permanent bench marks (including levels) must be placed strategically on site for use during construction. These are to be cast in concrete and labelled with an engraved aluminium plate stating the name of the benchmark.

A list of Trigonometric Beacons, control points and reference beacons used must be supplied with the plotted plans. The list must include the name, coordinates and levels (where applicable).
