

Bidders are expected to produce a parking strategy that will provide better accessibility to the St Peters precinct without compromising movement of traffic and comfortability of the neighboring properties.</p> <p>The appointed Engineer must focus on creating additional vehicular parking solutions as well as provide additional pedestrian access to the St Peters precinct site, located at 6 Gardner Circle, South End, Gqeberha, 6001.</p> <div style="text-align: center;">  </div> <p>The scope of works:</p> <ol style="list-style-type: none"> 1. Status quo -data collection, i.e. number of public parking and existing traffic demand. 2. Evaluate pedestrian movement, constraints and provide possible solutions. 3. Consider the overall transport implications in the broader area in terms of where the precinct is located and existing developments and cemeteries. 4. Present graphics and determine the required movement interventions. 5. Make recommendations on the traffic plan including modelling. 6. Make recommendations for safe tourist routes, from the Harbor, Airport etc.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other

method envisaged in legislation;

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:
