PLEASE NOTE:

1.) Date of award

The date of award is the date on which the appointment letter/s was sent to the preferred service provider/s. In some instances the regret letters are issued prior to the letter of award (appointment) and in some instances the letter of award (appointment) and regret letters are issued simultaneously.

2.) Appointment / Effective Date

The date of official appointment and on which the services commence, after the 14 day objection period has lapsed per clause 49 of the MBDA SCM Policy 2017, where persons aggrieved by decisions taken in the implementation of this supply chain management system, may lodge within 14 days of the decision, a written objection or complaint against the decision. The appointment /effective date is the date from which the appointment cannot be cancelled and is legally binding.

3.) 14 days objection period

The period of written objection or complaint against a decision, this is calculated from the day the regret letter has been issued to the unsuccessful service provider. As stipulated in clause 49 of the MBDA SCM Policy 2017, which states:

- "(1.) Persons aggrieved by decisions taken in the implementation of this supply chain management system, may lodge within 14 days of the decision, a written objection or complaint against the decision.
(2.) The successful bidder may not commence any work until the expiry of the fourteen (14) day period referred to in 49.1 or until such time as any objection or complaint has been resolved, whichever is the latter."
