DETAILED DESCRIPTION AND / SPECIFICATIONS	Operator to run the Rainbow Café at the St Peter's Rainbow Village Background MBDA undertook the project to stabilize the structure of the St Peter's Church ruins in South End. The greater project includes walkways around the site, the erecting of a deck and buildings to the south of the church and created access to the church ruins. The storytelling aspect of the remarkable past community of South End has been captured through storyboards, a rock garden decorated by the original residents of the area and a room that will allow visitors to enjoy the experience of the features and sounds of the old village. The MBDA is seeking to engage the services of a Service Provider to operate the café on the site. Applicants should have the capability to deliver an offering that will create compelling visitor experiences that complement and add value to the Rainbow Village concept. This should include a concept that features the Tastes of South End. The current infrastructure offers top-end kitchen equipment and benched seating on the adjacent deck. The attraction will be launched to the media and have regular initiatives to promote it to tourists, visiting groups of people, local customers and schools. A fixed monthly rental to cover utilities, electricity and water usage plus a proposed percentage of turnover. The applicant needs to outline the offer explicitly as part of the methodology.

SCOPE OF WORK

The Service Provider should render all services mentioned below in conjunction with the MBDA:

1. Experience

1. The Service Provider must have at least 1 year of experience in a similar café or catering business.
2. The ability to create storied culinary offerings.
3. The ability to offer an experience that will result in visitors posting positive comments on social media.
4. Experience in creating tasting events that will boost the media and tour operator coverage of the café.

2. Logistics

- a) The Service Provider must have staff who are familiar with serving visitors in a café, restaurant or event environment.
- b) Have standby staff available so that the service standards at the café are never compromised.
- c) Meet the expected operating and hygiene standards set by the MBDA.
- d) Allow a health inspector to pop in to evaluate hygiene standards.
- e) Meet with MBDA on a monthly basis to discuss the delivery at the café and come up with innovative ideas to develop the offering.

3. Knowledge

- a) The Service Provider should have a good historical knowledge of the old South End village and the community that lived here pre-1970.
- b) The Service provider must have knowledge and experience to deliver Halaal food and certified to serve Halaal foods.

4. Methodology

The applicant must submit a detailed plan on how they propose they will operate the café, in line with the scope of works as well as other revenue generating ideas.

5. Offer

Bidder must submit rental offer and percentage turnover payment to the MBDA. The café is fully fitted with all the equipment, from prepping the meals to the point of sale, and WiFi.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
