| DETAILED DESCRIPTION AND / SPECIFICATIONS           | <p>The MBDA hereby calls for suitably qualified service providers to provide proposals for Commercial Kitchen Design and Installation at St. Peter.</p> <p><b>1. Project Overview</b></p> <p>St. Peter requires quotations for the design, supply, and installation of a commercial kitchen comprising two linked containers: a <b>Prep Container</b> and a <b>Customer Container</b>, connected via a service hatch. The kitchen must meet commercial standards, using high-quality materials and efficient spatial design. The Prep Container will house most kitchen equipment and cabinetry, while the Customer Container will include a service area, counter fridge, and a coffee shop-style island bar.</p> <p><b>2. Scope of Work</b></p> <p>The supplier shall provide:</p> <ul style="list-style-type: none"> <li>• Design, fabrication, and installation of cabinetry, countertops, and specified equipment.</li> <li>• Relocation of the side room door in the Prep Container to the centre of the wall.</li> <li>• Relocation of the counter fridge to the former door area.</li> <li>• Installation of a service hatch linking the containers.</li> <li>• Compliance with health, safety, and commercial kitchen regulations.</li> </ul> |

### 3. Specifications

#### 3.1 Prep Container

The Prep Container houses primary kitchen equipment and cabinetry with the following requirements:

- **Cooker Hood** (Supplied):
  - Commercial-grade stainless steel.
  - Minimum extraction rate: [e.g., 1000 m<sup>3</sup>/h].
  - Features integrated lighting and noise reduction.
  - Positioned above griller and fryer for optimal ventilation.
- **Oven** (Supplied):
  - Built-in eye-level commercial electric oven.
  - Integrated into cabinetry for seamless design.
- **Microwave** (Not Supplied):
  - Commercial-grade microwave oven.
  - Positioned within cabinetry for easy access.
- **Prep Bowl** (Not Supplied):
  - Stainless steel single prep bowl with mixer, minimum dimensions: [e.g., 600mm x 450mm x 200mm].
  - Positioned at the counter end closest to the new sliding door.
  - Integrated into countertop with cupboards above and below.
- **Kitchen Cabinetry:**
  - High-quality melamine or equivalent material.
  - Double impact edging for durability, with stainless steel door handles.
  - Cupboards above and below prep bowl for storage.
  - Designed for maximum storage and accessibility.
- **Countertops:**
  - 32mm black mottled marble, polished finish.
  - Height: ~1m from floor level, suited to service hatch.
  - Edge profile: [e.g., bullnose or square edge].
  - Seamless integration with prep bowl and fixtures.

- **Door Relocation:**

- Move the (side room) door to the centre of the Prep Container wall.
- Install a treated wooden sliding door, slightly larger than standard for easy access.
- Ensure proper sealing and structural integrity.

- **Counter Fridge Relocation (Supplied):**

- Relocate the counter fridge to the former door area within (side room)
- Ensure electrical and ventilation requirements are met.

### 3.2 Customer Container

The Customer Container serves as the service area, linked to the Prep Container via a service hatch, with a coffee shop-style island bar. Requirements include:

- **Service Hatch:**

- Already in place

- **Island Bar Area:**

- Designed to standard coffee shop specifications with dual-height countertops.
  - Countertop: 32mm black mottled marble, polished finish, matching Prep Container.
  - Height: ~1.1m for bar seating.
  - Features:
    - Space for a commercial-grade coffee machine (supplied).
    - Prep bowl with mixer (not supplied), stainless steel, minimum dimensions: [e.g., 500mm x 400mm x 200mm], integrated into countertop.
    - Under-counter bar fridge (not supplied), minimum dimensions: [e.g., 600mm x 600mm x 850mm], with electrical and ventilation provisions for milk and coffee products.
  - Sufficient workspace for coffee preparation and customer interaction with place for a till etc.
- **Back Cabinetry and Display Fridge (Fridge Supplied):**
    - Cabinetry to integrate seamlessly with existing shelving, incorporating new cupboards.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
