Replacement of 100A isolator with a breaker and add 80A 3 phase breaker with 25 mm 4/5 core cable to the building and 24-way DB inside the building Facility Safety Compliance – Limit the load to mitigate core/cable from burning, load test to be conducted and ensure - that the electrical feed is installed to comply with SANS 10142-1.

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
