DETAILED DESCRIPTION AND / SPECIFICATIONS	The Mandela Bay Development Agency (MBDA) seeks quotations from experienced professional public art organisations, artist collectives, or individual artists/teams to design, produce and install a series of large-scale murals along Strand Street, now renamed Steve Biko Street. The programme aims to activate the public realm, celebrate local culture and stories, improve pedestrian experience and support cultural tourism objectives in Nelson Mandela Bay. Project brief: Nelson Mandela Bay has a very rich and diverse liberation heritage history. The “liberation heritage route” adds value to the existing ‘Route 67’ project of the MBDA and intends to unpack this story with murals of some of the significant leaders from the Eastern Cape. These include, but are not limited to, Govan Mbeki, George Botha, Nelson Mandela, Winnie Mandela, Vuyisile Mini, Maqoma, Nxele, O.R Tambo, Lilian Ngoyi, Bantu Biko, and a lot more. The names given are meant to give an idea of the composition of the “Liberation Heritage Route” The concept idea needs to consider the following; - Diverse liberation history of the Eastern Cape - Connection to the taxi rank - The Frontier wars of dispossession of the Eastern Cape - Maritime history/heritage - Vibrancy (character/diversity/life) - Friendly city - Working class community to and from the inner city

- Access and working-at-height systems (scaffolding, mobile elevating work platforms) and safe installation.
