DETAILED DESCRIPTION AND / SPECIFICATIONS	1. BACKGROUND The Mandela Bay Development Agency (MBDA) hereby invites suitably qualified and experienced artists, muralists, creative studios, or multidisciplinary service providers to submit quotations for the conceptualisation, design development, surface preparation, and installation of a large-scale exterior mural artwork at Bayworld in Gqeberha. The mural forms part of broader efforts to reposition and reactivate Bayworld as a public cultural, heritage and tourism destination through creative placemaking, visual activation and public art interventions. The artwork is intended to contribute to the enhancement of the public realm while creating a visually compelling landmark that reflects the identity, heritage, marine environment, and cultural significance of Bayworld and the surrounding precinct. 1. SCOPE OF WORKS The appointed service provider will be responsible for the full scope of works, including wall assessment, surface preparation, repair work where necessary, priming, artwork design, material supply, installation and final protective finishing. 	• Introduce a high-quality public art intervention within a strategic tourism and heritage asset; • Create an iconic and visually engaging mural artwork that celebrates marine heritage, biodiversity, culture and storytelling; • Improve the aesthetic quality of the precinct and strengthen placemaking outcomes; • Encourage public engagement and social interaction through art; • Support local creative industries and artists through commissioned public art opportunities. The successful service provider will be required to undertake the following: 2.1 Site Assessment and Preparatory Works • Conduct a detailed assessment of the existing wall condition; • Clean the wall surface thoroughly, including removal of dirt, debris, loose paint, mould, algae or contaminants; • Sand and prepare surfaces to ensure suitable adhesion; • Apply approved exterior-grade primers and sealants; • Ensure all preparatory works comply with industry standards for large-scale outdoor mural installations. 2.2 Design Development The appointed service provider must: • Develop and submit a minimum of three (3) original mural design concepts informed by the project brief; • Ensure that concepts respond to the identity and context of Bayworld, marine life, environmental sustainability, tourism, heritage, culture and/or public storytelling; • Present designs in high-resolution digital format with visual mock-ups showing placement on the building façade; • Include colour palettes, conceptual narratives and material specifications; • Participate in design review sessions with the MBDA and relevant stakeholders; • Refine and finalise the approved concept based on stakeholder input.

- Ensure use of high-quality weather-resistant and UV-resistant exterior mural paints and coatings;
- Apply anti-graffiti and/or protective coating where appropriate;
- Maintain a clean and safe working environment throughout the installation period;
- Ensure all work is completed in accordance with applicable occupational health and safety requirements.

2.4 Project Close-Out

Upon completion, the service provider must:

- Conduct final touch-ups and cleaning;
- Submit high-resolution photographs of the completed artwork;
- Provide maintenance recommendations and specifications for future upkeep;
- Provide a workmanship guarantee for the installation.
