DETAILED DESCRIPTION AND / SPECIFICATIONS	The Mandela Bay Development Agency (MBDA), acting on behalf of the Nelson Mandela Bay Municipality, hereby invites suitably qualified and experienced service providers to submit quotations for the design, manufacture, and installation of a building wrap at the Killer Whale Café located within Bayworld. This project forms part of the MBDA's strategic mandate to utilise creative placemaking and public art interventions to revitalise public spaces, enhance tourism experiences, and strengthen the cultural identity of Nelson Mandela Bay. Bayworld is a significant cultural and tourism asset within the City's beachfront precinct. The proposed building wrap intervention seeks to: • Enhance the visual quality and experiential value of the site • Activate underutilised infrastructure through public art and design • Improve visitor engagement and dwell time • Strengthen Bayworld's identity as a marine, environmental and educational destination • Contribute to local economic development through the creative Industries The Killer Whale Café has been identified as a high-visibility structure suitable for transformation into a landmark visual feature within the precinct.
