DETAILED DESCRIPTION AND / SPECIFICATIONS	1. PURPOSE & BACKGROUND The Mandela Bay Development Agency (MBDA), a municipal entity of the Nelson Mandela Bay Municipality hereby invites suitably qualified service providers to submit formal written quotations for the provision of cleaning services at the Tramways Building for a period of 12 months. These venues are used for mainly events from Monday to Monday. Most of the time the client would setup the day before the main event. It is highly likely that there would be back-to-back events on some weekends and some seasons. Cleaning of the above would therefore be required in-between these consecutive events. The client has got access to the venue from 08h00 until 23h00 and therefore needs the hall cleaned before the starting time and after the finishing times. A compulsory briefing meeting will be held at MBDA Office, Tramways Building, Corner Lower Valley Road & South Union Street, Central in Gqeberha at 10:00 AM on Wednesday, 26 August 2026. Bidders are urged to arrive timeously. The onus is on bidders to ensure that they arrive on time. No attendee(s) arriving after 10:15 AM will be allowed to bid.

The cleaning services are required for the **Tramways Building**, Corner Lower Valley Road & South Union Street, Central in Gqeberha across the following designated areas:

- Main Hall Cleaning with its Beverage Room (1200 square meters)
- Upper Foyer Cleaning (2900 square meters)
- Left Wing (300 square meters) and the cleaning of all their Toilets and Ablutions.
