The bidder must have an active ECSA professional registration (candidates will not be considered) and a proven track record in completion of a minimum of three (03) similar projects. The appointed engineer will be expected to undertake Principal Agent duties as per ECSA guidelines with a focus on the following services: 1. Identification of repair works needed on public infrastructure in all the MBDA managed precincts. 2. Preparation of specifications including drawings for the identified repair work where necessary. 3. Development of a BoQ for the identified repair work. 4. Preparation of estimates for repair work to be carried out. 5. Assisting client (MBDA) in preparing work packages 6. Monitoring and certifying completed repair work. 7. Issuing relevant completion certificates. 8. Project close out. NOTE: 1. The project has tight deadlines, and the appointed engineer will be expected to work within the given timelines.

5. The professional Engineer / technologist must be based within the NMB for the duration of the contract.
6. The RFQ requires services of the Engineer **ONLY**.
