DETAILED DESCRIPTION AND / SPECIFICATIONS	1. PURPOSE & BACKGROUND The Mandela Bay Development Agency (MBDA), a municipal entity of the Nelson Mandela Bay Municipality hereby invites suitably qualified service providers to submit formal written quotations for the provision of garden maintenance and cleansing services at the Tramways Building, The Science Centre, and on an ad hoc basis at other MBDA-managed facilities. The objective is to preserve neat, hygienic, and aesthetically welcoming urban areas within Nelson Mandela Bay. A compulsory briefing meeting will be held at MBDA Office, Tramways Building, Corner Lower Valley Road & South Union Street, Central in Gqeberha at 11:00 on Tuesday, 01 September 2026. Bidders are urged to arrive timeously. The onus is on bidders to ensure that they arrive on time. No attendee(s) arriving after 11:15 will be allowed to bid. For site inspection, arrangements must be made through on-site security to access and inspect both the Tramways Building and The Science Centre prior to submission. Bidders are strongly encouraged to conduct site visits to assess conditions, access, existing infrastructure and any site-specific requirements before pricing.

2. SCOPE OF WORKS & DELIVERABLES

The services are required for the Tramways Building and The Science Centre, as well as on an ad hoc basis at other **MBDA**-managed facilities. The appointed service provider will deliver garden maintenance, cleansing and associated services as follows:

2.1 WORK ORDER PROCESS

Step 1 — Order: The **MBDA** issues a written work instruction / purchase order stating the site, the tasks, the number of workers and the number of days.

Step 2 — Deliver: The service provider delivers the workers and equipment as instructed. The **MBDA** signs off the completed work.

Step 3 — Invoice: The service provider submits an invoice using only the quoted rates. Invoices are paid within 30 days.

Worked Example (i.e. how an invoice is calculated)

The MBDA orders 4 workers plus a supervisor for 5 days, plus removal of 2 LWB bakkie loads of garden waste, plus 1 day of a genie lift at your Rate 3, plus R1,000 of plants and compost bought from a nursery (mark-up quoted at 10%).

2.2 TIMELINES & DURATION

The contract period is anticipated to be for six (06) months and will terminate upon reaching the end of the contract period or the maximum contract value, whichever occurs first.

Any other durable tool or equipment that is reasonably needed to perform the scope of works, including blades, wear parts, servicing and maintenance of all of it.

The availability and use of the bakkie and trailer form part of standard equipment and may not be charged for. The only use of the bakkie that may be charged is the disposal of waste, which is charged per load at the applicable rate line. Any other use of the bakkie — moving workers, tools, equipment or materials etc — may not be charged.

If a load size not listed above is required, the rate of the nearest quoted size applies, adjusted pro-rata to volume. No other disposal charge of any kind may be added.
